

INFORMATION ON PROTECTION OF PERSONAL DATA in PLASTIMO JSCo

3. PLASTIMO collects, stores and processes personal data **only** in connection with the performance of its official duties and responsibilities, the purposes of which are related to:
 - labor relations;
 - commercial activity;
 - accounting;
 - control activity;
 - security;
 - legal-normative activity ;
 - information and technical activity;
 - Occupational Health Service;
 - other corporate or statutory purposes
4. The period of storage of the personal data for all corporate systems of PLASTIMO JSCo is **up to 12 months after the expiry of the statutory storage periods or 12 months after the expiry of the necessity under the purpose of the processing of the personal data.**
5. All persons whose personal data is collected, stored and processed in PLASTIMO JSCo have the following rights:
 - *the right of access* to information about the personal data processed by PLASTIMO JSCo;
 - *the right to correct* or supplement inaccurate or incomplete personal data;
 - *the right to erase ("the right to be forgotten") of personal data* that are being processed illegally or without a need (expired, withdrawn, accomplished purpose for which they are collected, etc.);
 - *right to limit the processing* - in the event of a legal dispute between PLASTIMO JSCo and the person until its resolution.
 - *data portability* - if processed in an automated manner on the basis of consent or contract. For this purpose, the data is transmitted in a structured, widely used and machine-readable format.
 - *the right of objection* - at any time and on grounds related to the particular situation, provided that there are no compelling legal grounds for the processing that take precedence over the interests, rights and freedoms of the data subject or the lawsuit.
 - *the right not to be subject to a fully automated solution involving profiling* that produces legal effects or significantly affects the data subject.
6. Persons who have provided their personal data to PLASTIMO JSCo if they believe that their rights under item 5 are violated have the right to file a complaint with the Personal Data Protection Commission or the court.
7. The submitted personal data of PLASTIMO JSCo are not profiled and no automated solutions are taken when processing them.
8. In order to prevent abuses in PLASTIMO JSCo, the following activities are carried out:
 - **video surveillance at the workplace;**
 - **control of entering and leaving the company;**
 - **control of the electronic means of e-communication;**
 - **workplace print control (internet, centralized printing, telephone, mobile phone).**
